2. The requisite items along with specifications for **Purchase of 79 Queue Management Software & Integration display system for Regional Passport Offices** are provided in **Annexure-I** of the bidding document.

3. Terms & Conditions for Submission of Proposals:

- National Tax Number (NTN) and Sales Tax Registration Certificate.
- The proposals must reach the undersigned on or before **03-02-2025 at 03:00 PM**.
- The Tender shall be evaluated on the basis of both Technical & Financial Proposals, single stage two (2) envelope procedure (Rule 36 (b) of PPRA Rules, 2004)
- Technical and Financial Proposals should be submitted in separate envelopes, the words 'Technical Proposal' or 'Financial Proposal' as the case may be, and **Tender No: 01/79/QMS/2025/LOG** being clearly written on the top of the respective envelope and both 'Technical and Financial Proposal' should be in one envelope.
- In the first instance, Technical Proposal shall be opened by a committee on **03-02-2025 at 03:30 PM** in the conference Room of this office. After technical evaluation, Financial Proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.
- A tender security in original amounting **Rs. 3,950,000/-** must be attached with the Financial Proposal in the form of a Pay Order/Demand Draft/Bank Guarantee in favor of Directorate General, I&P (Hqrs). Copy of the PO/DD/BG will be attached with technical proposals.
- All taxes shall be charged as per Government Rules on the subject.
- Directorate General, Immigration & Passports reserves the right to cancel or reject any/all tenders under rule 33, of the Public Procurement Regulatory Authority (PPRA) Rules, 2004.
- Incomplete and without bid security proposals shall not be entertained.
