- 3. PN Contingent Commander reserves the right reject any or all bids in accordance with PPRA Rules.
- 4. Bidding process is Single Stage Single Envelope.
- 5. As per prerequisite, the contractor must be security wise cleared and registered supplier with Pakistan Navy with good reputation. Moreover, contractor short-listing requires no default of blacklisting history from any Government and Public Sector/ Private Organization.

## SCOPE OF WORK/ TERM OF REFERENCE FOR HIRING OF VEHICLES:

- 1. PN Contingent requires vehicles on daily rental basis at Islamabad and Rawalpindi for PN Contingent.
- The total period of the contractor for hiring of transport will be considered from 31 January 2025 till 25 March 2025 OR as defined by the Contracting Authority.
- 3. The Contingent reserves the right to increase or decrease of quantity of vehicles in any category on requirement basis". The present requirements of vehicles are as under:

- 4. Due Restricted nature of duty, the bidder preferably should be registered with Pakistan Navy with valid registration. The Firm/supplier should provide relevant documents of registration and Tax history alongwith bid. None Registered Contractor/ Company will require to submit quote alongwith 05% Earnest Money of total contract value.
- 5. The bidder shall be registered/ active Tax payer of FBR. Provisions of necessary Certificate from FBR are a must and required to be attached with bid.

- The Contractor is to provide vehicle model not older than 03 years with Insurance Cover. Proof of the same is to be produced by registration copy of vehicle.
- In case of any extensive maintenance issue/ break down of vehicle(s), Contractor/ company shall immediately replace the vehicle(s) with same or up model in good condition without any arguments or litigation.
- The contractor/ company shall ensure that the documents of vehicle (Registration, road permit, tax and insurance documents/ fitness certificate etc) are complete and in accordance with applicable Government Laws and Regulations.
- Bidder must quote absolute/ fixed rates in bid to avoid confusion otherwise 9. incomplete bid shall not be entertained. No clause with "if & but" having finical impacts will be entertained and in such cases bid will be treated as non responsive and would be cancelled.
- The rate quoted by the bidder will remain the same throughout the period of the contract as mentioned.
- Service/ cleaning of the vehicles are the responsibility of contractor. The vehicle is 11. required to be cleaned and with full fuel capacity when called upon duty. However, cost of Engine Oil, Oil filter puncture etc related to vehicle will be provided by contractor.
- An affidavit on stamp paper must be attached with the bid of ownership of offered vehicle(s) that are proposed to be provided.
- All payments i.r.o Hired transport will be cleared/ done by PN Contingent upon completion of event.
