**PUBLIC AUCTION AT NO 102 AED, PAF BASE FAISAL**

2. **Inspection of various lots:** - Inspection of various lots of salvage stores will be allowed at 0830 Hrs on the auction day.
3. **Terms and conditions:** -
  - (a) The salvage stores offered for auction would be sold on "AS IS WHERE IS" basis without any guarantee or warranty of any nature whatsoever. No 102 AED, PAF shall not be responsible or liable for any fault, defect, dysfunction or any other problem with any Lot.
  - (b) The bidder shall participate in open bid on the basis of his own inspection and judgment.
  - (c) The bidder shall undertake to be liable and responsible for all losses or damages resulting from any fault defect or dysfunction of the items in Lot whether or not he opts to avail the opportunity to inspect the Lot as mentioned above.
  - (d) Computerized National ID card is mandatory for participation in bidding.
  - (e) No 102 AED, PAF reserves the right to accept or reject complete bid or a part of the bid, without thereby incurring any liability to the affected bidder, and / or any obligation to inform the affected bidder of the reasons for the action.
  - (f) No 102 AED, PAF shall neither be liable nor responsible for any costs, charges, expenses or damages of any nature whatsoever arising directly, indirectly or consequently on account of submission and / or rejection of bid (s).
  - (g) The successful bidder shall deposit **25%** of the bid value in cash on spot. Remaining amount (75% plus Taxes) is to be paid in **10 working days**. Delay would result in confiscation of earnest money (25%) or any other payment made in this regard in favor of government.
  - (h) Successful bidders will have to pay 'All applicable Taxes' as per existing Govt rules and DG DP policies.
  - (j) The successful bidder shall also be responsible to remove his lot from No 102 AED, PAF Base Faisal premises within **15 working days** otherwise ground rent charges would be levied as per prescribed government rules.
