- c. All the bids filled on prescribed Proforma should be duly endorsed, stamped, sealed and should comply with term and conditions.
- d. All the certificates pertaining to the registration of firm with tax authorities must also be enclosed.
- e. 05 % of bids security shall be deposited along with the tender documents as earnest money in the form of Call Deposit Receipt (CDR)/Demand Draft / Pay Order issued by any scheduled bank of Pakistan in the name of Director General, NIM, Lahore.
- f. Prices quoted should be inclusive of all applicable taxes which will be deducted by NIPA Lahore as per prescribed rules. Rates quoted should remain valid for the Financial Year 2024 - 2025.

 - vi. During local visit and In-land Study Tours following of all precautionary measures shall have the responsibility of the driver (s) with vicarious liability of the bidder.
 - vii. For coaster (s) the tool kits, accessories like rope and plastic sheet of best quality for covering the luggage of the participants will be ensured by the bidder.
 - viii. Certificates by the vendor regarding existing condition (s) of tyres alongwith spare one and so far milage covered by the vehicle with these tyres.
