b) The bid security shall be uploaded only in the shape of CDR in favour of Resident Engineer, (Civil) MDO Mangla (The name of firm must be mentioned on the CDR). The original CDR shall be submitted on or before the date of bid opening.

c) Bidder should attach successful completion certificate for similar works at least one during last five years

d) Bidder should attach the sufficient Cash Flow in shape of Bank Statement duly attested by concerned Bank.

 Presentation of false/wrong documents will be strictly discouraged and their CDR shall be forfeited besides black listing.

f) Affidavit (duly authorized on judicial stamp paper attested by Notary Public) in which the bidder under take that he is not involved in any litigation and no pending work in MDO shall be attached. The original Affidavit shall be submitted on or before the date of bid opening.

g) Affidavit (duly authorized on judicial stamp paper attested by Notary Public) in which it should be undertaken that he has not been blacklisted by any government/autonomous body shall be attached. The original Affidavit shall be submitted on or before the date of bid opening.

h) The Bidder shall attach PEC registration certificate and details of Active tax payer and will show the original documents at the time of bid opening.
