Envelope shall be marked as “Financial Proposal” and “Technical Proposal” in bold and legible letter to avoid confusion.

2. Who can Participate?

- (i) Contractor who has valid PEC registration renewal for the year 2024-25 under code as mention below.
- (ii) The average annual turnover with Tax return from FBR should be at least 100 Million for last 2 years, verified from the certified auditor & bank statement showing 15% balance amount of work.
- (iii) In proof of experience the contractor is required to submit valid work order in DISCOs along with work completion certificates executed during the last two years, which should be equal to the amount mentioned below, for same nature of work, from work order issuing Authority.

- (i) The Contractors are required to attach their registration certificates (Active), issued from PRA for PST / FBR for GST along with technical bid.

- (ii) In addition to experience the bidder has to submit documents/ company profile which prove that bidder has been involved in the Transmission Line work for the last two years and has sound financial position.
- (iii) The Tender will only be issued upon submission of original PEC registration.
- (iv) Authority letter is required on 100 rupees judicial paper for Contractor representatives to receive tender documents / participation in the tender process.
- (v) Cutting/ Overwriting is not allowed in tender documents.
- (vi) Tendered rates should be filled in figure as well as in words and tender should be signed as per general directions given in the tender documents.
