TENDER NOTICE

OUTSOURCING OF CONSERVANCY CONTRACT

Cantonment Board Malir (CBM) intends to outsource conservancy services in its area of jurisdiction. Therefore, CBM invites sealed bids for providing solid waste management services in Cantonment Board Malir areas by quoting lump sum rates on per month basis separately by considering all factors on the basis of “**single stage two envelopes procedure**” under Rule 36(b) of PPRA Rule 2004, from well established and reputed conservancy firms having minimum 03 years experience in solid waste management and who are on Active Taxpayers List of the Federal Board of Revenue. The contract will be for a period of 03 years extendable for a further period of 02 years on mutually agreed terms and conditions keeping in view satisfactory performance of firm / contractor and subject to approval of the Board.

SCOPE OF WORK:

REMOVAL OF GARBAGE BY MECHANICAL FLEET

- i. Daily garbage lifting from houses, commercial areas, collection points & garbage transfer stations (through compactor, dumpers and conservancy trucks with hydraulic system).
- ii. Daily removal of garden refuse / cuttings and dead animals.
- iii. Daily removal of debris and construction material from Malir Cantonment limits.
- iv. Daily removal of wild growth and leveling of open spaces and road sides with the help of tractor blade / front dozer.

The interested companies are required to submit their bids through SIGNLE STAGE-Two Envelops procedure as outlined in rule 36 (b) of the PPRA Rules, 2004. Each envelope shall contain separately the TECHNICAL PROPOSAL & FINANCIAL PROPOSAL and shall be marked as such in bold and legible letters to avoid any confusion. The bid validity period shall be ninety (90) working days after the bid is received and opened. The bids in sealed envelops must reach to office of undersigned by 05-11-2024 at 11:30 a.m. In case of non tendering on the above date, the tenders can be dropped in tender box on 07-11-2024 at 11:30 a.m. In case of non tendering on said two dates, the tenders can be dropped on 11-11-2024 at 11:30 a.m. Technical Bid will be opened at the same day at 12:00 p.m in the CBM main Office in presence of the bidders or their authorized reps who may wish to be present and financial proposal will be retained.

EVALUATION CRITERION:

1. The evaluation committee constituted by CBM shall first scrutinize the technical proposal based on the following consideration. Financial bids of only those firms will be opened who are pre-qualified as technically responsive. Sealed financial bids of technically non-responsive contractors / firms will be returned accordingly.

- a. Firm's profiles with permanent and present mailing address and phone numbers.
- b. NTN Certificate, CNIC copies and Income Tax clearance Certificate of previous years.
- c. Financial status, Bankers references/details, capital investment position, total value of assets/liabilities.
- d. Convincing evidence of technical and financial capability to under take and execute the work.
- e. Details of a comprehensive waste management plan for the entire Malir Cantonment.
- f. Detail of works executed and current contracts along with satisfactory performance report from the concerned departments.
- g. Alongwith above mentioned specification, details of equipments and machinery owned, leased or rented by the firm with certified copies of registration books will have to be provided with technical envelop. In case the firm / contractor offers hired or rented vehicles for the solid waste management services, it must enclose rental agreements with owners of vehicles alongwith original registration books with technical envelop.
- h. Details of machinery and equipments required for the contract. Conservancy hydraulic trucks / dumpers, compactor, 10 wheeler hydraulic dumpers & pickup shall not be older than 2015 model which will be Hino / Isuzu or equivalent make only. However, Front Wheel Dozer and tractors for shovel/auto loader, front blade and hydraulic trolley shall not be older than 2007 model.
- i. Details of technical and skilled staff for operation/maintenance.
- j. The bidders will have to attach detail of work experience of last three (03) years alongwith supporting documentary evidence with this tender.
- k. Physical inspection of equipment vehicles in working and functional condition will be carried out by the CBM during the technical evaluation.


FINANCIAL PROPOSAL

Consequent to the evaluation of technical proposal, the financial proposal of technically qualified bidders will be opened in the presence of the bidders or their authorized reps on date and time which will be informed letter on.

TERMS & CONDITIONS

1. Tender Form alongwith detailed scope of works, manpower, machinery, equipments etc and terms and conditions of contract is available at CBM Office which can be obtained during any working day in office hours on payment of Rs. 500/- (non refundable).

2. Firms/Bidders shall attach Bid security equal to 02% of annual bid amount with Financial bid in form of demand draft / pay order in favour of Cantonment Executive Officer, Malir Cantt and shall attach an affidavit with Technical Bid acknowledging the submission of Bid security and stating that the firm will be disqualified if the Bid security is not as per Tender instructions, which will be refundable after the acceptance of lowest bid.
3. Firms/Contractors will have to quote their monthly lump sum rates for solid waste management services (removal of garbage through mechanical fleet) the firms quoting lowest aggregates rates will be considered successful.
4. Affidavit of Firms/Contractor and owner being not black listed or in litigation with any Govt. department. Whoever has been declared to be black listed or in litigation with any of the Cantonment or Government / Semi Government Authority will be disqualified for awarding contract of conservancy notwithstanding the fact that the person has submitted tender and pursuance of such tender, has given bid even.
5. The successful firm/contractor /bidder will be required to execute an agreement with the Cantonment Board Malir on a non-judicial stamp paper of appropriate value within 07 days from the issuance of acceptance letter.
6. The firm shall maintain its own workshop for quick repair and maintenance of its vehicles, machinery, equipments etc.
7. The successful bidder will have to pay all the applicable taxes on existing Government rates or on rates prescribed by Government from time to time on total bid amount during currency of the contract according to the prevalent law.
8. The successful bidder/ firm shall deposit 05% of annual bid amount of contract as security deposit against satisfactory operation of the contract and shall be retained by the Board until satisfactory completion of the contract. The security deposit may be forfeited by the Board in case of failure on the part of the contractor to fulfill any of the condition of this contract, irrespective of and without prejudice to any other remedies which may be available against such failure.
9. As per PPRA Rules 33(1) of PPRA, 2004 the procuring agency (Board) may reject all bids at any time prior to the acceptance of bid subject to the provision of reason of rejections of bids.
