3. The bidder shall submit through courier / contractor representative 02% bid security sealed in envelope of the estimated cost in the shape of call deposit (original) from scheduled bank before tender closing date and time.
4. The tender shall be cast electronically on or before 06<sup>th</sup> January, 2025 upto 11:30 pm on the website (<https://etender.mlc.gov.pk>) and shall be opened on the same day at 12:30 pm in the presence of tenderer or their authorized representative, who may like to be present.
5. Conditional tender and tender without call deposit shall not be entertained.
6. Cantt Board / Executive Officer reserve the rights to reject the tender as per PPRA Rule No.33 (1) 2004 due to any reason thereof.
7. The validity of tender rates shall be upto 180 days as per PPRA Rules.
