1. Invitation to Bid

The Federal Public Service Commission (FPSC) invites sealed bids from eligible and qualified firms for the **repair and maintenance of furniture and fixtures** at FPSC Headquarters, Islamabad. This bidding process will be conducted through the **EPADS** platform to ensure transparency and compliance with **PPRA Rules**.

2. Scope of Work

- 4. Financially sound with audited accounts or bank statements for the last two years.
- 5. Not blacklisted by any government or private organization (affidavit required).

4. Instructions to Bidders

4.1 Bid Submission via EPADS

- 1. All bids must be submitted electronically through the EPADS platform via uploading.
- 2. Bidders must register/login on the platform at [www.eprocure.gov.pk].
- Follow the EPADS bidding instructions and upload the required documents in PDF format.

4.2 Bid Components

 - Company profile, list of completed projects, technical capacity, and workforce details.
 - Proof of experience to undertake repair of furniture (Annexure A).

• Financial Proposal:

- Itemized cost of repairs (as per Annexure A format).
- Bid price inclusive of all applicable taxes.

• A **bid security of 5%** of the total bid price must be submitted in the form of a bank guarantee or pay order. The original must be delivered to the FPSC office before the bid submission deadline.
