INVITATION OF BIDS - VACCINE

The Ministry of Religious Affairs & Interfaith Harmony, Government of Pakistan, Islamabad intends to invite technical and financial bids in separate sealed envelopes on Delivery Duty Paid (DDP) basis at the Committee Room of this Ministry from reputed original pharmaceutical manufacturers or registered importers or authorized agents duly registered with Income Tax and Sales Tax Departments as well as on the Active Tax Payers List (ATL) of FBR, having valid Drugs Sale Licenses duly issued by respective authorized Federal, Provincial or Regional Health Departments, for procurement of following Vaccines in accordance with due registration / approval of DRAP, Ministry of National Health Services, Regulations & Coordination, Government of Pakistan, Islamabad and the quantities mentioned against each:

| 1. | Meningococcal (Meningitis ACYW-135 Single dose as prefilled syringe / single dose vial with auto disable syringe / preferable multi dose vial with auto disable syringes). | 170,000 doses* plus 5% Free of Cost |
| 2. | Quadrivalent / Tetravalent Seasonal Influenza Vaccine, single dose, alongwith auto disable syringes / prefilled syringe. | 170,000 doses* plus 5% Free of Cost |

*Quantity can be increased or decreased accordingly as per finalization of actual number of Hujjaj.

2. All aspirant bidders should indicate the expected date of delivery of vaccines at EPI's warehouse NIH, Chak Shahzad, Islamabad as well as onwards distribution to the Directorates of Hajj all over Pakistan at their own expenses.

3. Interested eligible bidders may obtain bidding documents, containing detailed terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, clarification / rejection of bids, performance guarantee etc. on submission of written application along with payment of a non-refundable fee of Rs.5,000/- (Rupees Five thousand only) from <u>Pilgrims Welfare</u> <u>Section</u>, <u>Room # 18</u>, <u>Hall C,M/o Religious Affairs & Interfaith Harmony, First Floor, Kohsar Block, Pak Secretariat, Islamabad</u>. However, a copy of bidding documents can also be downloaded from EPADS and Ministry's websites at <u>www.mora.gov.pk</u> subject to payment of **Rs.5,000/-.** The amount of Bid Security (Earnest Money) and for procurement of bid documents is required to be deposited in the shape of a pay order/bank draft/call deposit receipt/bank guarantee in the name of Secretary (M/o RA&IH) Islamabad. Any financial proposal not accompanied by the pay order/bank draft/call deposit receipt/bank guarantee shall straightaway be rejected.

4. The bids, prepared in accordance with the instructions contained in the bidding documents for each of above-mentioned vaccines should be dropped forward through E-PADS <u>on or before 25.02.2025 at 1000 hours</u>. Bids will be opened on the same day <u>at 1030 hours</u> in the committee Room of this Ministry, in the presence of all bidders or their authorized representatives. All bids are invited single stage Two-Envelope procedure under PPRA rules 36(b). 5. No hard copies of bids / offered will be entertained if not forwarded through E-PADS by vendors during specified time.

 Bidders are requested to give their final prices as negotiations on the price once quoted/offered are not permissible under the Rules. The Competent Authority i.e., Secretary (M/o RA & IH) reserves the right to reject any or all bids at any time prior to acceptance of a bid or proposal as per Rule 33 (Rejection of Bids) of PPRA Rules 2004.
The Companies in dispute with this Ministry are not allowed to participate in the bidding process, unless the matters are settled before closing date of this bid.
