The applications shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tender documents will only be issued to scrutinized contractors. The Tender must be received in the office of **accepting officer by 1130 hrs on 10 Mar 25** and tender will be opened on 10 Mar 25 at **1200 hours**.

Note: Contractors shall provide certificate that they are not involved in any type of litigation with Govt Department in the court of law and no special report of Directorate of inspection & evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor borne on approved list of MES in categories 'A', 'B', 'C' 'D' & 'E' and also having experience of this type should only apply.

5. Contractor who desire may be present at the time of opening of tender.


6. The accepting Officer reserves the right to accept or reject the tender. Rejected will be dealt with as per Para-33(i) of PPRA Rules.
