Only bids through EPADS will be entertained and no other bid will be accepted except EPAD. Bids will be opened on same date and venue at 11:30 A.M in the office of the Divisional Accounts Officer, Pakistan Railways Rawalpindi in the presence of the representatives of the firms who want to be witness.

The Railway administration may reject all bids at any time prior to the acceptance of a bid. The Railway administration shall upon request communicate to any contractor who submitted a bid, the ground for its rejection of all bids.
