

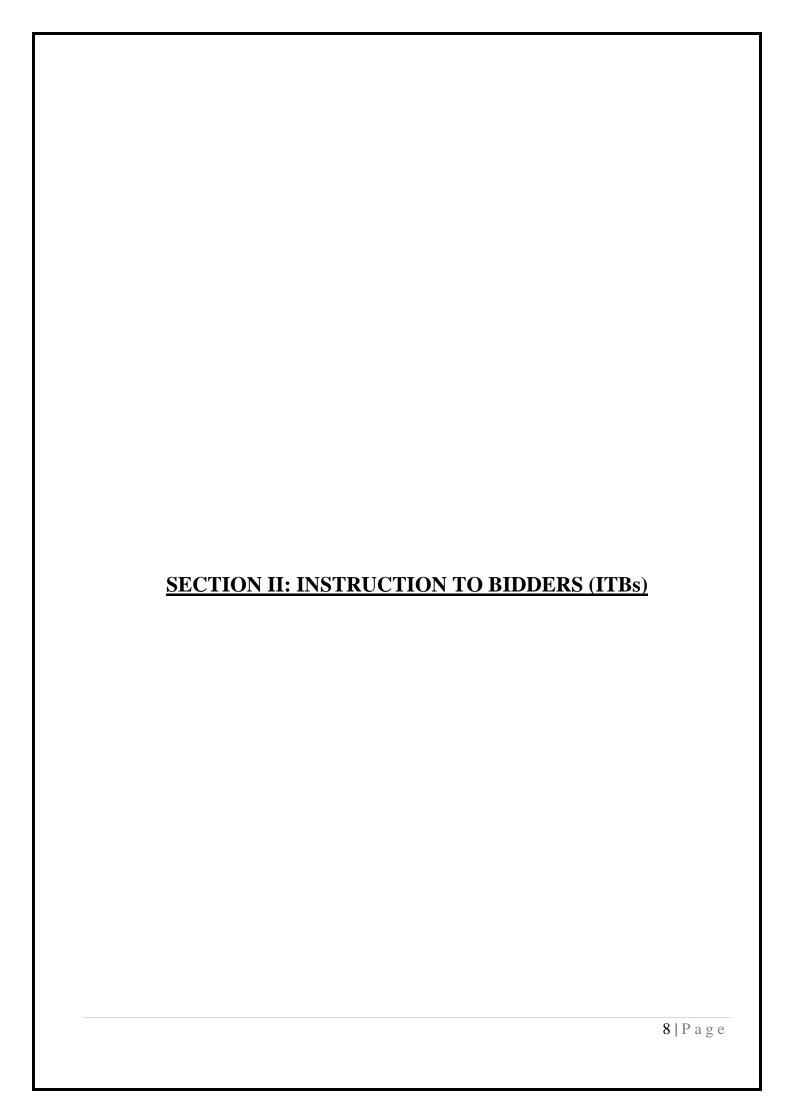

A. INTRODUCTION
