INVITATION FOR PRE-QUALIFICATION CRBC(LCG)/ICB-03

1. Pakistan Water and Power Development Authority (WAPDA) has been entrusted by the Government of Pakistan for the construction of Chashma Right Bank Canal (Lift-Cum-Gravity) Project and provided funds to finance the cost of Contract No. CRBC(LCG)/ICB-03 for the "Pumping Station and Allied Works along with Electro-Mechanical Works" of Chashma Right Bank Canal (Lift-Cum-Gravity) Project to eligible payments under contract for which this Invitation for Pre-qualification is issued.
2. The Pakistan Water and Power Development Authority (WAPDA) hereinafter the Employer intends to prequalify the contractors for the abovementioned works.
3. Pre-qualification is open to Contractors/ Joint Ventures of contractors who are registered with PEC in category C-A/no limit (in case of JV, the lead firm must fulfill the C-A category requirement while other JV partners must fulfill the category requirement as per their share).
4. Foreign firm(s) can come in JV in line with current PEC by-laws. Pakistani Firm(s) must be on active taxpayer list (ATL) of FBR in accordance with FBR current by-laws. Firms may obtain the prequalification documents from the office of the Employer from the address mentioned below.
