- i. The period for completion of the project shall be **09 months**.
- ii. Tender documents can be obtained during working hours (0900 Hrs. to 1600 Hrs.) on Monday to Friday from under- mentioned office, Islamabad against a fee of **Rs. 2,500/-**
- iii. Issuance of tender documents shall be closed one day earlier to the opening date.
- iv. Fixed Bid Security amounting to **Rs. 0.30 Million** in the form of **CDR or Bank Guaranty** from scheduled banks of Pakistan, as specified in Tender Documents shall have to be submitted along with bid. **However, if any bidder opts to submit Bank Guaranty, it must have an expiry date of atleast 6 months from the date of bid opening.** Otherwise, bid shall be rejected.
- v. Bid Security must be enclosed in a separate sealed envelope along with tender, with name of work clearly mentioned on the envelope.
- vi. Two copies of BOQ shall be submitted by bidder (one original & 2<sup>nd</sup> photocopy) and both shall be sealed, pre-signed and stamped and name of work shall be clearly mentioned on the envelope.
- vii. Rates shall be written in figures and words in separate columns. In case of conflict in figures and words, the rate quoted in words shall prevail.
- viii. Competent authority may reject any or all bids/ proposals at any time prior to acceptance of bid or proposal.
- ix. Tender will not be issued or accepted by Post/ Courier/ Telegraphic means.
- x. Tender Evaluation Committee reserves the right to demand the analysis of quoted rates to check their reasonability and workability.
- xi. Incomplete proposal/ bid may not be entertained and shall be treated as non-responsive.
