**Terms of Auction: -**

- The bidders must bring their original CNIC and provide complete address / telephone numbers and attested copy of CNIC on the day of Auction.
- The bidders must quote the rate for each item separately.
- The bidder to participate in the bidding process shall deposit a refundable bid security of **Rs.100,000/-** (Rupees: One Hundred Thousand Only) for the unserviceable items in shape of **Cash/demand draft** in the name of Branch Officer Admin-II, AGPR, Islamabad.
- Successful bidder must deposit earnest money i.e. **Rs.10 % in cash** on the spot and remaining amount must be deposited within **05 days** of auction. In cases of default, earnest money shall be forfeited.
- Withholding tax on the bid amount shall be charged, as per prevailing rules.
- All bidders can make queries/seek clarifications before the bidding; this office will not be responsible for any complaint later on.
- Possession of unserviceable items etc. will be given to the successful bidders only after making full payment. The successful bidder will be liable to make arrangements for shifting of goods/material within **one (01) week**.
- The Auction Committee/ Competent Authority reserve the right to accept or reject any or all bids in according with rule 33 of PPRA rules 2004.
