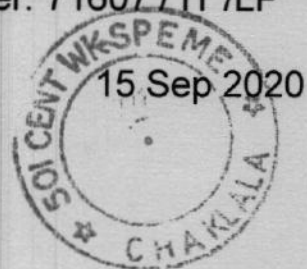

2. Rates

- a. Hard copy to tender Inquiry number 71607/IT/LP dated **15 Sep 2020** comprising nature / details of repair along with specifications is available and can be collected from the office of undersigned on any working day before **21 Sep 2020**.
- b. CST will remain valid till **30 Jun 2022** (Bid Validity).
- c. Quoted rates must be inclusive of all the Government taxes i.e. GST, Income Tax and others.
- d. Rates will be quoted in Pak Rupees only.

3. Quotations

- a. All the quotation should be submitted duly signed and stamped by each firm.
- b. The rep reporting to workshop for dropping the quotation should be in possession of **CNIC** which will be shown to the Gate Keeper.
- c. The firms are advised to quote maximum number of items so that each firm can be considered as active firm.
- d. No column should be left blank in quotation, however, **NQ** should be written in the rate column for ITEMS NOT BEING QUOTED.
- e. Firm should clearly mention "TOTAL NUMBER OF ITEMS QUOTED".
- f. No rate will be accepted through fax or any other electronic device/medium.
- g. No quotation will be accepted after prescribed time under any circumstance.

5. Tender Opening


- a. The quotation should be dropped in tender box before **1000 hrs** on **05 Oct 2020**.
