Terms and Conditions

- The bidding shall be conducted online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of ML & C Department i.e. (<u>https://etender.mlc.gov.pk</u>)
- E-bidding shall be done on above / below percentage of MES Schedule of Rates 2021 in BOQ, All bidders are required to have valid NTN, Active Tax payer list status and PEC registration of relevant codes are eligible to apply with proper PEC registration renewal 2024-2025.
- 3. The tender shall be cast electronically on or before _______Dec, 2024 upto 12:30 pm on the website (https://etender.mlc.gov.pk) and shall be opened on the same day at 01:30 pm in the presence of tenderer or their authorized representative, who may like to be present.
- 4. The bidder shall submit through courier / contractor representative 02% bid security sealed in envelope of the estimated cost as mentioned above in the shape of call deposit (original) from scheduled bank 01 day before tender closing date and time.
- Conditional tender and tender without call deposit shall not be entertained.
- Cantt Board / Executive Officer reserve the rights to reject the tender as per PPRA Rule No.33 (1) 2004 due to any reason thereof.
- The successful contractor shall enter into prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Gujranwala within 07 days of issuance of acceptance letter.
- The validity of tender rates shall be upto 180 days as per PPRA Rules.

In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) reasonable amount decided by the undersigned in the call deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
