- A Bidder shall be a natural person, private entity, or government-owned enterprise who is active tax payer Registration with PPRA, including the use of EPADS, and SECP, FBR, KPRA, valid NTN Number.
- Overall, 05 Year of establishment of the Service Provider
- Having Experience, Qualified Staff, Financial Position and other Conditions as required in the detail Bidding documents

Terms & Conditions:

2. National Competitive Bidding (NCB) will be conducted in accordance with **Single Stage Two Envelopes method.**

- A complete set of Bidding Documents can be downloaded from EPADS at (<http://www.eprocure.gov.pk>). The tender documents, contain detailed instructions/terms & conditions and specifications, are available for registered bidders. Alternatively, the bidding documents may be purchased a day before closing time & date of the bid, upon payment of a non-refundable fee of Rs. 3,000 (Rupees Three thousand only).
- The prospective bidder shall submit PKR3,000,000/- (Three Million Rupees Only) as Bid Security in the form of a Bank Guaranty or CDR (Original sealed Copy) from any scheduled bank of Pakistan, made out in favor of the CEO PESCO, Peshawar, before the bid closing time, failing which the bid(s) shall be considered 'non-responsive' and rejected.

- The bids have partial and incomplete documents shall be rejected.
- A bidder may submit a bid for any one, more than one, or all Lots as specified in the schedule. Each bidder shall clearly indicate the specific Lot(s) for which they are submitting a bid in their proposal, on prescribed PESCO bidding documents duly signed and stamped. Those who failed to submit their bids on prescribed PESCO bidding documents shall be declared non-responsive.
- Conditional bids shall not be accepted.
- All the information and documents provided in e-Bid on E-PADS by the bidder must be based on facts beyond any doubt. Any misrepresentation, false statement or fake document found in the proposal at any stage, would lead to debarment / blacklisting of the Firm.
