OPEN AUCTION OF INTEGRATED MANAGEMENT & OPERATION OF PORTER SERVICES (HAND TROLLEYS) FOR SECURITY AND FORWARDING OF AGRICULTURE PRODUCES AND OTHER GOODS IN THE MARKET AREA OF I-11/4, ISLAMABAD.

The Market Committee, intends to award the right (outsources) for the INTEGRATED MANAGEMENT & OPERATION OF PORTER SERVICES (HAND TROLLEYS) FOR SECURITY FORWARDING OF AGRICULTURE PRODUCES AND OTHER GOODS IN THE MARKET AREA (FRUIT & VEGETABLE WHOLESALE MARKET AREA) I-11/4, Islamabad on annual basis through open auction for a period of two years. The auction will be held in the office of CHAIRMAN MARKET COMMITTEE FRUIT & VEGETABLE WHOLE SALE MARKET, I-11/4, ISLAMABAD on 11-04-2025 at 11:00 AM. Further details are as under:-

- 1) The immense/potential bidders (income tax registered and active tax payer ON FBR) participating in open auction should have minimum 02 year practical experience in handling the work INTEGRATED MANAGEMENT & OPERATION OF PORTER SERVICES at any sites in the country like Airport , Shipyard, Air Port , Railway station, Market Areas, and other industrial yards etc. and shall have to deposit Rs. 300,000/- (Rupees Three Hundred thousand only) as earnest money in shape of pay order / Demand Draft in Favour of Market Committee ICT along with the copies of CNIC, NTN, Bank Statement for last one year before 3-days , the commencement of the auction, for qualification to participate in the bidding process
- 2) The possessions/work order of the site shall be handed over after fulfillment of all codal formalities viz payment of advance quarterly installment, acceptance of offer letter/performance guarantee, and provision of security amount (10% of bid value), and payment of 10% Advance tax to FBR.
- 3) The Market Committee/auction committee, reserves the rights to cancel/ reject the auction or any or all bids proceeding as a whole or any individual bid as per PPRA rules.
- 4) The details Terms & Conditions of the auction and license can be obtained from the office of the Market Committee, I-11/4 Islamabad during office hours @ Rs. 10,000/- (Rupees Ten thousand only) non-refundable up to 12-04-2025.
- 5) Re-auction shall be held on 14-04-2025 at 11:00 AM in case 1<sup>st</sup> auction is canceled/ not succeeded due to any reason.
