### MILITARY ENGINEER SERVICES TENDER NOTICE

1. Applications for pre-qualification of contractors/firms are invited by the GE (Army) Pano Aqil Cantt for the issue of tenders of following works in the light of PPRA Rules 33 (1) of 2004.

2. The contractors are required to submit their applications to GE (Army) Pano Aqil Cantt for issuance of tender documents alongwith their credentials as shown at ser 4 below. The applications shall be scrutinized and the tender docus will only be issued to the firms / contractors who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. The sealed tenders will be received in the office of accepting officer by **07 May 2024** till 1130 hrs and will be opened at 1200 hrs on the same date.

**Note:** Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the court of law and that no special report of DI&E (E-in-Cs Branch) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractor not registered with PEC are ineligible to apply.

4. Firm / contractors not borne on approved list of MES will furnish their applications alongwith statement of previous experience, giving details of works executed during last two years and those in hand on proforma appended below:-
