3. The bidder shall submit through courier / contractor representative 2% bid security in envelope of the estimated cost in shape of call deposit (Original) from schedule bank before closing date time.
4. The tender shall be cast in electronically on **04** Aug, 2024 upto 1100 hours and shall be opened on the same day at 1130 hours in the presence of tenders or their authorized representatives, who may like to be present.
5. Conditional tender and tender without call deposit shall not be entertained.
6. Cantonment Board Abbottabad reserves the right to demand analysis of the quoted rates from the concerned bidder, to check their reasonability and workability.
7. The quoted rates shall be valid till the completion of work and in any case no escalation shall admissible on any pretext.
