The Second envelope containing the price shall be clearly marked as "FINANCIAL BID" accompanied with Bid Security.
- 5. Two envelopes "Technical Qualification" and "Financial Bid" must be delivered at Embassy of Pakistan, Al-Farabi Road, East Villas, Mezzeh Damascus at or before 11:00 AM on the above mentioned date. The Envelope "Technical Qualification" shall be opened at 11:30 AM on the bid opening day.
- 6. The "Financial Bid" of bidders who fail to POST QUALIFY shall be returned UNOPENED. Upon technical verification, the envelope "Financial Bid" of Post Qualified Tenderers will be opened at 11:30 AM in the presence of Tenderers representatives on the date to be intimated in due course of time.
- 7. Bids received after the above deadline shall not be accepted. Telegraphic/ Telex/ Fax bids shall not be accepted.
- 8. Payment will be made as per the conditions signed in the contractor agreement between the Embassy of Pakistan and the Contractor and approved by the committee constituted for the said purpose.
- 9. Application, on the letter head of the company, may be addressed to the Head of Chancery, for obtaining bid documents. The bid document fees is SYP 100,000/- which is non-refundable.
