

For evaluation of proposals, SINGLE STAGE/ TWO ENVELOPE Procedure will be adopted. The envelope containing the Technical Proposal shall be clearly marked "Technical Proposal" that will include the information & copy of latest Fard Malkiyat (فرد ملکیت) for record, Aks-Shajrah (شجرہ عکس), Geographical map clearly mentioning all features on East, West, North and South sides of proposed site(s), Google Earth map of proposed area along with all documentary evidence in form of undertaking on non-judicial stamp paper of minimum value Rs. 100/- that Land Owner(s) or Land Provider(s) are willing to sell proposed land for the purpose of construction of New 132kV Grid Station. Standing Committee of GEP/CO Site Selection will visit the proposed sites submitted in the form of Technical Proposals by interested Land owners or Land providers.
