1. The National Skills University Islamabad invites sealed bids from eligible firms to undertake the work titled as “**Renovation of Iqra Block Phase-II at National Skills University Islamabad**”.
2. The invitation of bid is open to firms meeting following criteria:
 - I. Having valid registration with Pakistan Engineering Council (PEC) in category C-4 or above and having specialization in CE-09, CE-10 & EE-11.
 - II. Active taxpayer as per FBR’s database i.e. active taxpayer (ATL).
 - III. Having similar work experience i.e. Civil works of PKR 100 Million or above with documentary proof.
 - IV. Affidavit on stamp paper (that the firm has not been blacklisted by private, Govt., Semi Govt. and Autonomous Body)
3. The bidding action shall be undertaken on the basis of PPRA Rule 36(B) “**Single Stage-Two Envelope (SS-TE)**” open bidding procedure. The firms capable of carrying out this work are advised to furnish complete information in accordance with the requirements of bidding documents.
