1. The National Highway Authority (NHA) intends to engage Individual Consultant for hiring of “Consultancy Services for External Monitoring of the Implementation of Land Acquisition and Resettlement Plan Central Asia Economic Corridor (CAREC) Tranche-III Projects”.
2. RFP documents can be downloaded from NHA's website www.nha.gov.pk free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days by written request on consultant letter head accompanied with pay order/demand draft amounting to Rs. 1,000/- (non-refundable) in favor of National Highway Authority.
3. Pre-Proposal Conference will be held on **23rd September, 2024 at 1130 hours** in the NHA Auditorium (HQ) Islamabad.
4. Bidding will be carried out by adopting “Single Stage Two Envelops” procedure. The Proposals complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or before **9th October, 2024 at 1130 hours** in NHA Auditorium, 27-Mauve Area, G-9/1, Islamabad and be clearly marked “*Consultancy Services for External Monitoring of the Implementation of Land Acquisition and Resettlement Plan Central Asia Economic Corridor (CAREC) Tranche-III Projects*”.
5. Bidders are required to submit their bids strictly in accordance to Instructions to Bidders, Bidding Data Sheet of Bidding/RFP Document and NIT. Proposals must be prepared in hard book binding form to deny the possibility of addition or removal of page(s).
6. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of only technically qualified Individual consultants shall be opened after finalization of technical evaluation. Other details are provided in the RFP.
7. All the applicable Federal, Provincial & Local taxes must be considered while preparing the financial proposals. All these taxes are required to be built-in in the quoted rates and GST is to be mentioned separately.
8. The Individual Consultants providing unsubstantiated and/or incorrect information are liable to legal action and/or disqualification.
