### **CONSTRUCTION, OPERATION, MANAGEMENT AND MAINTENANCE OF FILLING STATIONS ALONGWITH ALLIED FACILITIES ON UCH SHARIF SERVICE AREA, KM-679+700 (NORTH & SOUTH BOUND) ON SUKKUR – MULTAN MOTORWAY M-5 (SECTION OF PESHAWAR-KARACHI MOTORWAY) ON RENTAL BASIS**

1. Sukkur - Multan Motorway M-5 (Section of Peshawar-Karachi Motorway) is a long access controlled Motorway, which is an integral link of CPEC (China – Pakistan Economic Corridor).
2. National Highway Authority (NHA) will provide site (detail given in RFP) out of already constructed Service Area for the establishment of filling stations (Petrol, Diesel and CNG/LNG) alongwith allied facilities. NHA envisages to engage Oil Marketing Company(ies) (OMCs) duly registered with SECP, having valid license from OGRA or Authorized Retailers/Dealers of any OMC, {having proof of established and running fuel station(s)} for Construction, Operation, Management and Maintenance of Filling Stations (Petrol, Diesel and CNG/LNG) along with other facilities. The time period of this contract will be ten (10) years on advance quarterly Net Guaranteed Rental basis and extendable for a period of two (02) years on satisfactory performance and mutual consent of both parties, subject to approval by NHA.
3. **The successful bidder shall construct, operate, manage and maintain the filling stations (Petrol, Diesel and CNG/LNG) alongwith allied facilities at Uch Sharif service area at its own cost.** On completion of contract period, the entire construction/established amenities will become property of NHA and the operator will hand over all of the amenities/installations to NHA in a properly maintained and operational condition without any claim to cost.
4. The Request for Proposal (RFP) document (comprising detailed terms & conditions, scope and requisite Forms etc.) can be obtained from the office of DD (FR/HB) NHA-HQ, Islamabad during office hours after **19<sup>th</sup> September, 2019** against deposit of Rs.2000/- (non-refundable) in form of pay order in favour of National Highway Authority Road Maintenance Account. RFP can also be downloaded from NHA website ([www.nha.gov.pk](http://www.nha.gov.pk)) free of cost. The interested bidder(s) will provide requisite documents as per the RFP for the establishment of filling stations (Petrol, Diesel and CNG/LNG) and allied facilities in the technical proposal.
5. A pre-proposal conference is scheduled to be held on **Thursday 26<sup>th</sup> September, 2019 at 1130 hrs** in NHA Auditorium, Islamabad. The RFP complete in all respects is to be submitted on or before **1100 Hrs on Wednesday 09<sup>th</sup> October, 2019** in NHA Auditorium, Islamabad. Technical Bids will be opened on the same day at **1130 hrs**.
