5. Items will be purchased according to the availability of funds. The quantity of items can be enhanced / reduced in the public interest.

3. If Government introduced/imposed Income tax policy then income tax policy then income tax will be deducted from selected supplier.
4. Items will be purchased according to the availability of funds. The quantity of items can be enhanced/reduced or deleted in the public interest.
5. The quotation reached without call deposit or after due date shall not be entertained and Conditional quotations shall be treated as non responsive.
