**TERMS AND CONDITIONS**

Bids are invited from reputable firms for provision of digital parking management services at NSTP, NUST, H-12 Islamabad. Parking area comprising of approximately 103,125 sqft has capacity to handle around 300 cars and 280 motor bikes.

**1. Qualification of the Vendor**

The following Firms/Suppliers are eligible to apply and required to submit the following documents with their proposals.

- i. Valid registration certificate with relevant tax authority NTN/STRN etc.
- ii. Certificate of Active Taxpayer List
- iii. Full address and contact numbers of the office(s).
- iv. Relevant experience of the bidder
- v. Submit work orders of previous clients.
- vi. Affidavit on stamp paper mentioning that the Firms/Supplier that have never been blacklisted by any Government Agency or Authority.
- vii. Submission of bids security

**2. GENERAL**

- i. Bidders are required to submit bid security (3% of bid amount) in form of bank draft/ pay order in original in the name of NSTP, NUST at the time of opening of Technical Bid.
- ii. Conditional/incomplete tenders will be not accepted.
- iii. Bidders are required to apply for all category of services.
- iv. NSTP reserves the right to accept any part or all services quoted.
- v. Telephone/telexed/faxed/telegraphic/emailed quotations will not be entertained.
- vi. Bids submitted without prescribed Earnest Money shall be liable for rejection at the time of tender opening. Earnest money shall be submitted along with tender. The cheque is not acceptable.
- vii. Bidders are required to include all applicable taxes in their prices/rates.
- viii. Loading, unloading and transportation of goods will be the supplier responsibility.
- ix. Items' rates and amount should be filled in figures as well as in words and should be in accordance with the general directions given in tender documents. Overwriting and cutting will not be acceptable.

**3. METHOD OF PROCUREMENT**

Bidding will be conducted by using a “**Single Stage – Single Envelope Bidding**” procedure. Qualification criteria is provided in Annexure-III and Financial evaluation criteria is provided in Annexure-IV.

**4. SCOPE OF SERVICE**

The bidder shall provide parking management services by using technology as per specifications given in the **attached Annexure-I**.

**5. CURRENCIES OF BID**

The prices shall be quoted in Pakistani Rupees.

**6. EARNEST MONEY:**

The bidders shall furnish, as part of his bid, earnest money @ 3% of their bid price in the form of bank draft/pay order by a Pakistani scheduled Bank in favor of **NSTP, NUST**. The Earnest Money may be forfeited if a bidder withdraws his bid during the period of his bid validity or failed to fulfill the contract agreement / PO.

**7. LATE BIDS**

Any bid received by the Purchaser after the prescribed deadline for submission of bids shall be returned unopened to the bidder.

**8. PURCHASER’S RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS:**

The NSTP reserves the right to reduce or increase the number of services, or reject any/all bids as per rules.

**9. CONVINCING**

Unsolicited advice/clarification and any personal approaches at any stage of evaluations are strictly prohibited and may lead to disqualification.

**10. DELIVERY OF ITEMS**

The bidder shall make delivery of equipment at his own cost within the specified period from the date of issuance of Purchase Order from the NSTP.

**11. MODE OF PAYMENT**

Payment will be commenced after complete installation, inspection, acceptance and testing of equipment. Furthermore, payment invoice will be calculated from the date of commissioning (excluding dry run and testing period) of digital parking management system. Payment will be made in Pak. Rupees after deduction of all Government taxes with payment term of net 30 end of month (EOM).

- i. Selected bidder will be required to manage vehicle parking area in NSTP comprising approximately total area of 103,125 sqft. This area includes approximately 8,521 sqft of motor bike parking.
- ii. Selected company will provided parking management services from 0800 hrs. to 2000 hrs, 5 days a week (Monday, Tuesday, Wednesday, Thursday and Friday).
- iii. Management of approximately 300 cars parked in parking area and around 280 bikes parked in separate designated bike parking area.
- iv. Two separate points of entry and exit need to be established in parking area.
- v. UHF based or equivalent auto entry and exit system.
- vi. Installation of CCTV system both at entry and exit points.
- vii. Provision and installation of barrier system at both points.
- viii. Provision of computer systems for operation of parking lot.
- ix. UHF Tags or equivalent will be provided by selected bidder.
- x. Provision and installation of UHF cards reader or equivalent.
- xi. Provision of furniture and cabins for staff.
- xii. Cabling, networking and maintenance of equipment will be responsibility of bidder.
- xiii. Provision of any other equipment require for commissioning of digital parking system.
- xiv. Provision of human resource (1 X Technician, 2 X Marshals, 1 X Reliever) for management of car parking.
- xv. Provision of parking software.
- xvi. All human resource related cost (direct and indirect, boarding, lodging and meals) will be borne by selected bidder.
- xvii. In case of any mishap or accident related to staff and equipment bidder will be solely responsible.
