1. Office of **AGE (Army) Defence Complex Islamabad** invites sealed tenders for the following works in the light of PPRA Rule 13 (1) of 2004.

2. The Contractor are required to submit their application for issuance of tender documents along with their complete credentials as shown at serial (3). The application shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tenders must be received in the office of the Accepting Officer by **1130 hour** by **23 Dec 2024** and tender will be opened on **23 Dec 2024 at 1200 hours.**

NOTE:- Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ Rwp) is outstanding against them.


3. Firms / Contractors not borne on approved list of MES may also apply and they will deposit earnest money @ 2% of estimated cost and will furnish a certificate along with their applications, giving details of works executed during last two years and those in hand on the proforma appended below:-
