- 3) Consultancy firms are required to submit a comprehensive Technical Proposal in English (Original + One Copy) and Financial Proposal (Original + One Copy) in separate sealed envelopes for the services required in the Terms of Reference (TOR's) latest by December 14, 2024 at 11:00 AM. Technical Proposals will be opened in the Tender Opening Committee meeting on the same date at 11:30 AM in the presence of the firms or their representatives who choose to attend at the same address.
