Areas of SAP Certifications/ modules are on Government IFMIS on FI, HR, ABAP, BASIS, Process Orchestration, SAC (planning), SAP Green ledger, Special ledger, SAP Material Management, Asset Recording, SAP GRC(ETD), Process Control etc.

The Proposal shall be conducted in line with "Single Stage-Two Envelope" procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential Service Providers. Method of selection will be QCBS with 70% Technical and 30% Financial weightage for a period of 12 months, extendable on performance

Original Proposals (Technical and Financial) must be submitted separately in two pdf format files through EPADS, addressed to "Project Director Implementation of Online Billing Solution (SEHAL) on or before submission deadline above.

Interested firms must also submit original Proposal Security [in hard form] in favor of Project Manager, SEHAL of PKR 1,000,000/- in the form of Pay order, Bank Guarantee, Bank Draft with a validity period of 148 days, before 1100 hours PST on the proposal opening date before 1100 hours PST.
