- 3. All Bids must be accompanied by a Bid Security of minimum 3% (refundable) of the *total* bid price in shape of Bank Draft/Pay Order issued by schedule Bank in favor of ETI-GB must be attached with the bid document.
- 4. Bids received after the due time and date will summarily be rejected.
- 5. The competent authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals but shall not be required to justify those grounds.
- 6. Since the services and goods are required for Regional coordination Unit Baltistan therefore the firm/ dealers/ shops must be physically exists in Baltistan region.
- 7. ETI-GB can increase or decrease the quantity of requisite items.
