NOTICE INVITING EXPRESSION OF INTEREST (EOI)

EXPRESSION OF INTEREST FOR OPERATION OF SMART ENERGY METER VENDORS FOR SALES OF SMART ENERGY METERS FOR THE CONSUMERS OF WATER & POWER DEPARTMENT, GILGIT - REGION

It has been decided that all new electricity connections in future in Gilgit-Region shall be allowed only on the condition that Smart Energy Meters will be installed by the prospective consumers and meter change shall be allowed for all existing consumers on the condition that such change shall be accomplished with a Smart Energy Meter only.

The Water and Power Department, Gilgit Region is seeking expression of interest from such suitable vendors, who are WAPDA approved manufacturers of smart energy meters and have at least **05 years** experience of manufacturing, to start operation either directly or through authorized representatives by opening outlets in all areas falling under jurisdiction of Gilgit-region **(4 Districts Gilgit, Ghizer, Hunza and Nagar).** The deadline for submission of proposals shall be 14th September, 2019. The venue for submission of bids shall be Computerized Billing Section, Water & Power Complex, near KIU, Gilgit.

The proposed vendors shall quote the selling prices to be collected from the consumers. The lowest rates quoted shall be taken as reference for all those vendors, who are interested in selling the meters, for the following type of meters.

Terms & Conditions

- The vendors will provide space online (web based activity) for day to day management of smart meters without needing to have separate software.
- 2. The approved lowest rates shall remain applicable on all vendors for a period of 01 year.
- The serial numbers to be provided to the consumers shall be furnished beforehand to Water and Power Department and connections shall only be allowed on such numbers.
- 4. The qualified vendors shall have to submit an annual fee of Rs.0.100 Million for operation to be deposited with Water and Power Department, Gilgit-Region.

5. The qualified vendors shall have to ensure presence in all districts of Water & Power District Gilgit-Region to facilitate electricity consumers.
