Auction 2020-21

1. Open Auction of the unserviceable store items/goods “on as is and where is basis” shall be conducted in front of the Auction Committee and all bidders, at 11:30 AM on 10/11/2020 at FIA Office, Samungli Road, Quetta.
2. Items (goods) can be inspected at FIA Office, Samungli Road Quetta, on any working day during official hours.
3. The bidders must bring their original CNIC and provide complete address/telephone numbers and attested copy of CNIC, along with application through dully filled/signed Auction Form on the day of Auction i.e. 10-11-2020.
4. The goods shall be sold/auctioned to the highest bidder. In this regard decision of the Chairman Auction Committee shall be final.
5. Successful bidder shall have to deposit 30% of the bid price in Cash on the spot. Otherwise bid will be treated as invalid.
6. The successful bidder shall have to deposit the entire balance amount of the bid, along with all the applicable government Taxes, within (03) three days, after approval of the bid acceptance. Otherwise the bid shall be treated as cancelled and 30% deposited amount shall be forfeited.
7. All the applicable taxes shall be collected in addition to the bid amount.
8. The sold/auctioned items (goods) must be lifted by the successful bidder within three (03) days, after full payment at their own arrangements/risk and costs.
9. The competent authority reserves the right to cancel, accept or reject any or all the bids, without assigning any reason.
