## Pre-Qualification for Hosting of Virtual Dedicated Web Server for NUMS Web site

- 1. Documents for Prequalification are required from reputed IT related Firms / Service providers to host services for Virtual Dedicated Web Server (Web Hosting Services) for NUMS Web-site who are registered with Income Tax and Sales Tax Department and whose names are on the Active Tax Payer List (ATL) of FBR. Bidders who owns multiple data centers, cloud server and fiber deployed in Pakistan are eligible to participate. Pre-qualification process will be conducted according to rules 15 & 16 of Public Procurement Regulatory Authority (PPRA). NUMS will not be responsible for any postal delays whereas documents sent through email shall not be accepted.
- **3.** Documents prepared in accordance with instructions in the tender documents, must reach at the address mentioned at the end on/before the due date & time. Last date for the submission of envelops / documents is <u>07-Jan-2025 (Tuesday)</u> up to 1100 hours. Envelops shall be opened on same day by Tender Opening & Evaluation Committee at/after 1130 hours in front of all participating firms or their authorized representatives (who may choose to present) in Seminar Room, Crown Complex, NUMS PWD Campus, Police Foundation-Islamabad.
- **4.** Interested Firms / companies must ensure submission of their business details / documentary evidences indicated in the Prequalification Documents. Applications received without valid documentary evidence, supporting documents and necessary details requested in the Prequalification criteria or documents are liable to be rejected. The shortlisted or qualified firms will be informed in due course of time and will be invited further for submission of their Technical & Financial proposals through formal request.
