1.0 SCOPE OF WORK



The objective of this consolidated bidding document is to procure/install the Solar Equipment under the head of Upgradation of PAS Secretariat (Furniture/ Fixture) of PC-1. The procurement includes "Upgradation of Existing 15 kW Solar Electric Power Generation System to On-Grid 50 kW Capacity with Net-Metering (Supply, Installation & Commissioning)" for the PAS Secretariat Building, Islamabad. Under Sub-Component 1.5 of the PAS/PSDP Project.

#### 2.0 GUIDELINES FOR THE PROJECT

Bidders are advised to bid for the following earmarked projects where broad details of BOQ (Bill of Quantity) are given along with generic specifications.

2.1 Upgradation of Existing 15 kW Solar Electric Power Generation System to On-Grid 50 kW Capacity with Net-Metering (Supply, Installation & Commissioning)

#### 3.0 BIDS SUBMISSION REQUIREMENTS

The objective of the bid submission requirement is to provide bidders with the information to submit their bid in response to this Tender Document according to the specifications defined in this Tender Document and in order/sequence as outlined in this document. A Bidder who has responded to any previous Tender Document issued by the Pakistan Academy of Sciences (PAS) should not assume that the requirements are the same, as may have been in the past. Bidders (i.e., firms, not the individuals) must follow the following requirements and standards in the preparation and submission of their proposals/bid.

3.1 PPRA rule 36 (b) shall be adopted:

Single Stage Two Envelope bidding procedure: -

- (i) PPRA rule 36 (b) least cost method shall be adopted i.e. technically qualify but financially lowest.
- (ii) The Vendor is required to submit Technical Bid and Financial Bid in separate envelopes.
- (iii) Bids will include the prices quoted for each equipment as at (Annexure -B) in Pak Rupees
- (iv) The quoted prices must include all taxes, customs and freight charges for delivery and installation of equipment at the required location as mentioned in Annexure-A at their own risk and cost.

No Bid shall be entertained without bid security. Bid security will be part of the Technical Proposal. The Bid Security of the successful bidder will be released upon completion of the project.
- (vi) If the Bid is withdrawn before the expiry of its validity or the supplies/services are not made /provided within the due date, the Earnest money will be forfeited in favour of the Pakistan Academy of Sciences (Islamabad).
- (vii) The successful bidder will be required to deposit Ten Percent (10%) of the total contract value as Performance Guarantee in the form of a Bank Guarantee/Pay Order issued by a scheduled bank of Pakistan in favour of "Pakistan Academy of Sciences" at the time of signing of contract agreement/issuance of work/purchase order and will be released after one-year successful operation of the solar equipment.
- (viii) Proposals sent to the Pakistan Academy of Sciences (PAS) by fax or email vill not be accepted.

- Bidders are required to submit their proposals conforming to the specifications and terms & (xi) conditions provided in the Tender Document
- Failure to abide by any Instructions of this Tender Document may, at the PAS's sole discretion, result (xii) in rejection of the Bidder's Proposal and disqualification. (xiii)
- PAS has no obligation to locate or acknowledge any Information in the Vendor's Proposal that is not presented under the appropriate outline according to these instructions and at the proper location.
- Bidder's Proposal/Bid/Offer must be received, physically at the office of Director Administration, (xiv) Pakistan Academy of Sciences, 3-Constitution Avenue, Sector G-5/2, Islamabad, as well as apply to PPRA-EPADS (e-Pak Acquisition and Disposal System) by the date and time specified herein. PAS will not be responsible for any delays in delivery or expenses for the development or delivery of proposals. Any Proposal/Bid/Offer received after the Proposal/Bid/Offer submission date and time
- Bidder must provide an electronic copy of the submitted bid along with all supporting documents (xv)after the relevant bid opening if asked. (xvi)
- Bidder must fully respond to each requirement within the technical specifications by fully describing the manner and degree by which the Bid meets or exceeds said requirement(s).
- It is the responsibility of the Bidder to identify all costs associated with any item or series of items in (xvii) this Tender Document. The Bidder must include and complete all parts of the Cost Proposal in a clear and accurate manner. Omissions, errors, misrepresentations, or inadequate details in the Bidder's cost proposal may be considered as valid ground for rejection of the Bidder's proposal. Costs that are not clearly identified will be borne by the Bidder. The Bidder must complete the respective "Cost Information Submission Form" Annexure B in this Tender Document, which outlines the minimum requirements for providing cost information. The Bidder should supply supporting details as described in Annexure B, "the Cost Information Submission Form".
- Bidders are required to fill and sign page(s) of the Annexure B while following the format given, and (xviii) submit it as Financial Proposal. Financial Proposals not following the given format may lead to the rejection of bid. Soft copy can be provided if required.

### 4.0 SELECTION PROCEDURE

- 4.1 The intent of PAS in issuing this Tender Document is to award a contract to the quality, lowest evaluated bid and best responsive Bidder who meets the required standard of specifications and other factors including the mandatory requirements as indicated in the document.
- 4.2 The bidder firm shall have to obtain the minimum technical qualification marks of 65 out of a total of 100 marks to qualify for inclusion in the next stage for opening financial bids (Annex-E). Financial bids of the firms, obtaining less than 65 the minimum qualification marks shall not be opened.

### 5.0 GENERAL TERMS AND CONDITIONS

The following General Terms and Conditions for this Tender Document are mandatory.

- Last date of receipt of Bids is 13 June, 2024 by 1400 hours and the proposals will be opened on the same 5.1 day at 1440 hours. Bidders' conference/ pre-bid meeting may be held about a week before opening the

- An affidavit to the effect that the firm has not been blacklisted by any Sovernment/Semi-Government Organization (Specimen of Affidavit Annexure-F).

5.4. The bidder/firm must be AEDB Registration, SECP Registration, Pakistan Engineering Council (PEC): C-5 Category with Code EE-11 (Solar Energy), and Pakistan Power & Infrastructure Board (PPIB): C-2 Category (up to 500kW Solar System).

5.5. Undertaking that the Company / Firm/by individual JV members Is/are not blacklisted by Provincial or Federal Government Department, Agency, Organization or autonomous body anywhere in Pakistan. An affidavit on

stamp paper shall be provided (Annex-C).

5.6. Valid evidence showing the Company / Firm/by Individual JV members has/has never been litigated, will allow participating in the bidding process. An affidavit on stamp paper shall be provided.

- 5.7. Must provide details and evidence of 03 Nos. relevant experiences during the last three years for projects having a capacity of greater than 200kWp (each) (Annex-D).
- 5.8. Manufacturer's Authorizations for Solar Modules, and Inverters.

5.9. Warranty declarations.

5.10. The Secretary General, PAS reserves the right to accept/reject all bids.

5.11. On request of the bidders, PAS shall intimate the reasons for the rejection of bids but will incur no liability on this

account nor is required to justify the rejection of bids.

5.12. An effort by a Bidder to influence PAS, directly or indirectly THROUGH UNFAIR MEANS in PAS's proposal evaluation, proposal comparison or contract award decision, to meet or discuss with any PAS official unless desired by the PAS may result in rejection of the Bidder's Proposal and blacklisting for any future tender of PAS.

5.13. All responses to this Tender Document shall become the property of PAS.

5.14. PAS will not bear any expense incurred in the preparation of the proposals in response to this Tender Document.

5.15. Prices quoted in the bid must be valid for 90 days. After the contract, the firm shall not have the right to change the price. All prices must be quoted in Pak Rupees and must clearly state all applicable taxes which must be included in the quoted price. The bid validity period will also be the same (90days).

5.16. In no case, the bidder shall offer an alternate brand for his quoted brand.

5.17. PAS will not allow any compensation to the Selected Bidder for any variations in the rate of exchange of rupee against the dollar or any other currency. No additional claim arising out of change in legislation, exchange rate variation or any sort of taxes will be entertained.

5.18. The Bidders must Bid for an integrated solution.

5.19. As per BOQ, Supply, Installation, configuration, testing and commissioning of all the mentioned equipment will be

the responsibility of the firm/bidder.

5.20. Bidders must not type in or otherwise alter or re-key any of the original text of this Tender Document. If the PAS determines that the bidder has altered any language in the original Tender Document or amended/changed/deleted/substituted any terms and conditions of this Tender Document, the PAS in its sole discretion will disqualify the bidder from further consideration at any stage. The Tender Document issued by PAS is the official version and will supersede any conflicting Tender Document submitted by the bidder.

5.21. Bids are liable to be rejected if they are not conforming to the terms, conditions and specifications stipulated in

this Tender document.

5.22. During the examination, evaluation and comparison of the bids, the PAS at its sole discretion may ask the bidder for clarifications of their bids. The Bidder's cooperation during the evaluation process in providing PAS staff with adequate responses to requests for clarification will be considered a factor in the evaluation of the Bidder's overall responsiveness. Lack of such co-operation may at the PAS's discretion, result in rejection of the Bidder's Proposal.

5.23. The amount submitted as Earnest Money shall be refunded to the unsuccessful bidders after decision of the

"Tender Committee" for the award of said tender.

5.24. If there is a discrepancy between the unit price and the total price in the submitted bid which is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between the words and figures, the amount in words shall prevail. If there is a mistake in addition/ totalling, that shall be corrected.

5.25. The bld security is required to compensate PAS against the consequences of:

5.25.1. Subsequent unauthorized variations and/or modifications of the terms of the bid.

5.25.2. Premature withdrawal of the bid before completion of the bid evaluation.

5.25.3. If the bidder does not accept the correction of his bid prices which is in the Interest of the Commission.

5.25.4. Failure of the bidder to sign the resultant Contract, in the event of such Contract being awarded to it.

5.25.5. The occurrence of any of such events as solely judged by PAS, will entitle PAS to Torreit tie bid security.

- 5.26. Incomplete and conditional bids will not be entertained.
- 5.27. For this tender, all updates/changes shall be communicated through email.
- 5.28. In case of any dispute between the two parties regarding any matter arising after signing the contract agreement, the case shall be referred to the Secretary-General, PAS whose decision shall be final and binding on both parties.
- 5.29. The Bidder indemnify PAS against all third-party claims of infringement of patent, trademark industrial design rights arising from the use of the goods or any part thereof in Pakistan.
- 5.30. PAS or its representative shall have the right to inspect and/or test the equipment to confirm their conformity to the contract specifications. The Technical Specifications shall specify what inspections and tests PAS requires and where they are to be conducted. PAS shall notify the contractor, in writing, of the identity of any representatives entrusted for this purpose.
- 5.31. Only transactions, amendments, changes and/or variations in this Tender Document that are in writing from PAS and duly agreed upon by PAS shall be considered official. No negotiations, decisions, or actions executed by the Vendor as a result of any discussions with any PAS employee shall be considered official.
- 5.32. In case of delay, the Secretary-General, PAS reserves the right to impose a penalty @ 1% of the contract amount on daily basis for the total number of days delayed. However, the penalty should not exceed 10% of the contract amount.
- 5.33. If the work is not executed according to the satisfaction of the PAS, the Secretary-General, PAS reserves the right to reject it altogether or impose a penalty not exceeding 10% of the total amount of the contract.
- 5.34. If the work is not to the satisfaction of the Secretary-General, PAS, the Secretary-General, PAS has the right to cancel the order, and get work done by some other firm at the risk and cost of the vendor, subject to the condition that if the PAS has to pay any amount in excess of the agreed amount, the difference will be recovered from the vendor.
- 5.35. The bidders are required to submit an Integrity Pact on a Stamp Paper of Rs. 100/- attested by Notary Public as per sample attached to Annexure-G in case, the Bid amount is equal to or exceeds 10 Million Rupees.
- 5.36. Refurbished and end-of-life/sale equipment shall not be acceptable.
- 5.37. The items delivered shall be according to the items mentioned in the Bid and no bidder shall be allowed to change brand name or quality of items without the official approval of the Secretary General, PAS.
- 5.38. #### 6.0 HARDWARE AND SERVICE REQUIREMENTS

Following are the minimum hardware and service requirements which the Selected Bidder/vendor will be required to fulfil.

- 6.1. Delivery and Installation should be at Campuses of deployment at the risk and cost of the successful bidder.
- 6.2. Vendor must install all equipment and components and must ensure that the proposed equipment is fully operational and functions properly at all variables.
- 6.3. Vendor must provide adequate protection to install equipment against electrical surges and related issues.
- 6.4. Vendor must ensure that all systems are in first-class working condition and free of short circuits, and ground loops. In addition, the new equipment has to be integrated by the vendor with the already installed equipment/system.
- 6.5. At the time of installation, the Vendor must provide owner's manuals, manufacturer's data sheets, and a complete equipment list.
- 6.6. At the time of installation, the Vendor must provide comprehensive system schematics, and labelling and show detailed connections to all equipment.

Vendor shall provide on-call support (5 days a week) including assistance with operation and maintenance of the system at respective location(s) all free of cost for a minimum period of two years from the date of the first successful start/functioning/operation of the equipment and subsequent issuance of site acceptance. If a piece of equipment has to be taken out from the PAS in warranty for repair, the vendor has to provide a replacement (free of cost) for the time being to avoid interruption in routine/online activity.

6.8. A site survey may be required at no cost to PAS to determine specific project efficacy at any location. Any components needed during installation resulting from failure to perform a site survey must be provided at the

Vendor's expense.

### 7.0 WARRANTY

The following Warranty clauses apply to the equipment under this tender.

- 7.1. The successful Bidders shall warrant the equipment and its components to be free from any sort of defects in material and workmanship for (a) a minimum warranty given by the manufacturer for the solar panels and the inverter as specified in BOQ; and (b) a minimum period of Two years for the remaining non-consumable supplies from date of completed installation, testing and commissioning shall repair or replacement on a timely basis any defective component, assembly or portion free of cost. Technical support should be available on a call basis. Every call will be attended by competent staff of the Bidder within 3-4 hours of its notification either by phone or email or in writing during business hours (9 am 5 pm). A delay in attending the call and delay in rectification of the fault will lead to consequential financial damages to the Vendor/Bidder.
- 7.2. The Successful Bidder will warrant that the equipment supplied under the Work Order/Purchase Order are new, un-used, and incorporate all recent improvements in design and materials and which should be of good quality as per acceptable standards. Quoted equipment should meet all design, quality and other technical requirements listed in this document or explicitly mentioned somewhere else in other such projects.

#### 8.0 PROJECT IMPLEMENTATION PLAN

The Bidder should provide a detailed Project Implementation Plan as part of the Technical Proposal. This will be the basis for ensuring that the Project Implementation is regulated under defined timelines. This will also form the basis for the PAS to claim Liquidated Damages, for inclusion in the Contract, relating to delays, besides supplies and services not conforming to specifications, and/or other Contract commitments.

#### 9.0 MEET OR EXCEED SPECIFICATIONS

For all categories/lots, the specifications provided in this Tender Document are the minimum requirements of PAS. Bidders are advised to meet or exceed these specifications to meet the actual requirements of this Project and its successful practical implementation. But in such cases, additionally, proposed or altered specifications should be clearly highlighted to enable PAS to clearly identify the modified specifications.

### 10.0 TERMS OF PAYMENT

- 10.1. No payment shall be made in advance to the Contractor as mobilization advance.
- 10.2. Fifty percent (50%) cost of equipment shall be paid and will be released after the successful delivery of equipment and after approval of the committee that the items meet the proposed specification at sites as given In Annexure-A.
- 10.3. Thirty percent (30%) cost of equipment shall be payable to the Contractor upon successful installation, integration, testing & commissioning of equipment as elaborated in the Scope of Work specifically and in Tender document generally.
- 10.4. Twenty percent (20%) cost of equipment shall be payable to the Contractor upon the Performance Assessment Test (PAT) and Final Acceptance Test (FAT) of project deployment which will be conducted no less than two (02) months subsequent to the commissioning of all the equipment.
- 10.5. All payments will be made through cross cheque in the Pak Rupees. Taxes will be deducted at source as per government rules at the time of payment.
- 10.6. If the progress of the work is not to the satisfaction of the PAS Technical Committee, the Committee has the right to cancel the order with appropriate approvals, get the work done from a third party selected in accordance with the PPRA rules subject to the condition that if the first party has to pay any amount in excess of the agreed amount, the difference will be recovered from the second party.






