Bidding will be conducted through "National Competitive Bidding" using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, revised November 2017, August 2018 and November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 4. Interested eligible bidders may request further information by email addressed to <u>addldirector.prr@fbr.gov.pk</u> during official Business Days and timing at the address given below, latest by Seven (07) days before the deadline for the bid submission date.
- 5. The bidding document in English may be downloaded from <u>https://www.fbr.gov.pk/</u> without any fee(s)/ charge(s). The document in hard/ printed form; on specific request via official email or printed over official letterhead duly signed and stamped by the authorized signatory, can be sent through courier for a non-refundable amount of **PKR 15,000** or an equivalent amount in a freely convertible currency.
- 6. Bids must be delivered to the address below on or before **11:30** AM dated **10<sup>th</sup> June**, **2024**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on i.e., **10<sup>th</sup> June**, **2024** immediately after the bid submission deadline.
- 7. All Bids must be accompanied by a "Pay Order/ Demand Draft/ Call Deposit Receipt" or "Bank Guarantee" equivalent to two percent (2%) of the bid value issued by a scheduled Bank located in Pakistan (for Local Bidders) or country of incorporation/ registration (for International Bidders), as per the details/ requirements given at the respective section(s)/ clause(s).
- 8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
