The participants interested to purchase vehicle (s) shall must have to deposit a refundable/adjustable Pay Order/Demand Draft amounting to Rs. 25,000/-(Rupees Twenty Five Thousand only) in favour of National Highway Authority M-1 along with copy of valid CNIC, as Expression of Interest/Token money (Mandatory Requirement), failing which no person shall be allowed to participate in auction process.
