- The bidding shall be conducted online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of ML & C Department i.e. (https://etender.mlc.gov.pk)
- 2. E-bidding shall be done on above / below percentage of MES Schedule of Rates 2021 in BOQ, All bidders are required to have valid registration with PEC and valid NTN.
- 3. The tender shall be call electronically on or before 3-7 , 2024 upto 12 (2021) and the website (https://etender.mlc.gov.pk) and shall be opened on the same day at _____ pm in the presence of tenderer or their authorized representative, who may like to be present.
- 4. The bidder shall submit through courier / contractor representative 02% bid security in sealed envelope of the estimated cost in shape of call deposit (original) from scheduled bank before closing date and time.
- 5. Conditional tender and tender without call deposit shall not be entertained.
- 6. Rates shall be quoted on above or below the MES Schedule of rates, 2021 (amended from time to time).
- 7. Cantt Board Kharian reserves the rights to reject any one or all tenders after without assigning reason as envisaged in PPRA Rules 2004.

In case the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit reasonable standing security (refundable after successful completion of the work) decided by the undersigned in the shape of Call Deposit within 07 days.
