04. All Contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.
- 05 Contractors born on approved List of MES in Category 'B' 'C' & 'D' or other Governments for "No Limit" and having experience of this type of work may only apply.
- 06 Contractor who desire may be present at the time of opening of tenders.
- 07 The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
