TERMS AND CONDITIONS.

- 1) Interested bidders can only submit their bids online through e-Tender Portal of ML&C Dept (https://etender.mlc.gov.pk).
- Contractors having valid NTN No, STRN No and PEC Registration of relevant codes are eligible to apply.
- 3) The cutoff time for submission of online bids will be <u>1500 hrs</u> dated <u>22 cet</u> and shall be opened on same day at <u>1530 hrs</u> electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) If for any reason, office remains closed on the date of tender, it will be opened on next working day.
- 5) The bidders are required to submit a demand draft not less than 2% of bid price as earnest money / security in shape of Call Deposit of successful bidder will be refunded after expiry of warranty period.
- 6) E-tenders without attachment of deposited challan of tender document fee and call deposit/ bid bond in favour of the undersigned equal to the earnest money will be rejected.
- 7) The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Korangi Creek within 07 days of issuance of acceptance letter.
- 8) The issuance of work order shall be subject to approval from Board.
- 9) The validity of tender rates shall be upto 180 days as per PPRA / PEC Rules.
- 10) In case if the lowest bid is less than reasonable rates (10% above/below than the ruling %age as circulated by E-in-C's Branch letter No.2005/22/A/Ruling %age/DP&W/E2 dated 20th April 2023), the lowest bidder shall have to deposit standing security 10% bid amount (refundable after successful completion of the work) in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
- 11) The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
- 12) The Cantonment Board/ Executive Officer reserve the right to reject the tender as per PPRA's Rule No.33 (I) due to any reason thereof.
- 13) The CDRs uploaded online shall be deposited in the office on the same day of opening of bids. In case of failure the bids submitted will be rejected.
