
The said application shall be mandatorily accompanied by the following documents.

1. PEC valid registration for CFY (2024-25).
2. PEC relevant category and Code.
3. CNIC of the prospective bidders/firm.
4. Enlistment with procuring Agency.
5. Affidavit of no litigation and no blacklisting.
6. Renewal receipt for CFY (2024-25)
7. Signature of bidder / witness on bidding documents is mandatory.
8. Late submission of bid will not be entertained.

TERMS & CONDITIONS:

- a. 2% Bid security as specified in shape of CDR/TDR from any schedule Bank of Pakistan.
- In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1st Class shall be mandatory. The bidder quoting rates below 10% of T/S shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between T/S & Bid) in shape of CDR/Bank Guarantee from any schedule bank.
- b. In case of failure to produce the required deferential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited
