- Bid security 02% (as per PPRA Regulation) should be submitted / uploaded in shape of CDR from any scheduled bank of Pakistan in favor of “The Controller (Procurement Cell), PBC, HQs, Islamabad”.

TERMS & CONDITIONS

1. Participating bidders should be potential bidders having enough relevant experience for supply & installation of equipment as mentioned in tender inquiry # ENG/PROC-4(258-B2)/24 in public & private sectors within Pakistan.
2. The participant bidders can survey the project sites prior to bid submission.
3. The bidders may participate for any items/equipment, works mentioned in bidding document as per their area of expertise categorically on D.D.P. turnkey incoterms basis and as a complete solution.
4. Completion period is 60 days for all items.
5. Bidders must have import license to import the tendered equipment (where applicable).
6. In case Government announces any public holiday or due to unavoidable circumstances (Force Majeure) the tender will be opened on next working day.
7. Technically qualified bidder's financial position must be strong enough to procure the tender equipment and technically capable to supply and configure as per requirement of PBC. Under any circumstances the supply shall not be delayed due to dearth of bidder's financial position as well as due to his technical inability.
8. 2% Bid security (in shape of CDR) must be submitted against total quoted amount in the name of Controller Procurement Cell, PBC, Headquarters, Islamabad, (at the time of Bid submission Rule 25 of PPRA Rules 2004). A photocopy of 2% bid security CDR must be enclosed in technical envelope with amount properly hidden/blackened. Any bid security not validated from Bank can result into penal consequences. Bids without 2% CDR will not be entertained and no bid will be accepted after cutoff time.
9. Bidding documents/RFP can be downloaded from Radio Pakistan website: www.radio.gov.pk and PPRA EPADS portal in that cases Bidding Documents Fees will be collected by downloading CDR at the time of bids opening in the office of Procurement cell PBC, Hqrs Islamabad.
10. The proposal can be uploaded on unit cost based and the quantity of items/equipment, works shall be decided as per project site requirement or as mentioned in bidding document.
11. Bidders blacklisted by PBC or involved in litigation or found to be indulged in corrupt or fraudulent practices or bidders with bad reputation in after sales services or causing unnecessary delay in the past projects with PBC or bids found in contravention of PPRA rules at any stage of procurement will be considered non-responsive and will not be entertained by PBC.
12. Competent authority reserves the right to accept/reject any or all tenders as per PPRA Rule 33 (I).
13. PBC may increase or decrease the quantity of equipment as mentioned in the RFP/Bidding Document.
14. The specification of equipment/items can be seen in bidding document.
15. Successful bidder shall be bound to execute an agreement with PBC and all the terms & conditions including tender notice shall be binding on the bidder.
