- 2- All (03) Vehicles and different kind of Scrap can be inspected at Quetta Airport along with original CNIC only one day i.e. (11<sup>th</sup> & 12<sup>th</sup> December,2023) during working hours i.e. 10-30 – 15.30 PST only.
- 3- 10% Income Tax is applicable as per Govt. regulations which will be added up in offered rates. Highest bidder will be required to deposit total amount inclusive of 10% Income Tax with Accounts Officer against Cash Receipt.
- 4- Earnest money of the successful bidder(s) will be returned back against their bid value and will be required to submit remaining amount in shape of Pay Order or Cash Receipt with PIA Account Office within three working days after the Management approval, otherwise PIA reserves the right to forfeit Earnest amount. Only Pay Order will be accepted. Bank Guarantees call deposit, cheque and any other payment instrument will not be entertained.
- 5- After the Management approval, the successful bidders will be required to lift up the sold material within 15 days only after making the full payment to the Corporation. After 15 days, PKR 10,000/= per day, will be charged as Warehouse/parking Charges. And this Concession will only be for next 15 days. In case, successful bidder fails to lift up / remove the sold out Aircraft Hull even after the elapse of 15 days, Management reserves the right to forfeit the Earnest money and or remaining material.
