



**TERMS AND CONDITIONS FOR THE SUBMISSION OF TENDER**

1. Tender must be sealed and addressed to the Secretary, Federal Board of Intermediate & Secondary Education, H-8/4, Islamabad. Unsealed Tender is liable to be rejected. Conditional tender shall not be entertained.
2. The word **Tender for Rental Based Solution of Heavy Duty Digital Variable Printing (Black & White) for FBISE** must clearly be written on top of the envelope of the bid/tender documents.
3. All bidders are bound to provide material according to the approved specification.
4. Samples of all the items whose rates are to be quoted may be seen in the Purchase & Store Section before quoting the rates to avoid anxiety after submission of bid. For clearance of any ambiguity (if any) found in the bid documents may be discussed with the Assistant concerned of the Store Branch.
5. After having made agreement and receipt of work order items must reach in the office within specified time limits.
6. The payment would be made after receipt of quality report from the end user.
7. Income and Sales Tax will be deducted at source as per Government Rules.
8. The earnest money will be forfeited and all others measure will be adopted as per PPRA Rules including blacklisting if the tenderer fails to honour his quoted rates, or if he does not abide by other terms and conditions of the job.
9. In case of any dispute the Chairman of the Federal Board shall be the final authority to give decision, which will not be challengeable in any court of law.
