The vehicles will be deployed round the clock with the DISCOs Support Unit (DSU) in SEPCO's operational areas.
- 2. The prospective bidder must:
 - · Provide a copy of firm's registration certificates with relevant authorities.
 - Be registered with FBR (NTN & GST) and listed as an active taxpayer,
- complying with income tax laws.
- Preference will be given to those firms who have more then 02 years of
- experience in providing transport hiring services to corporate or government entities.
- Meet other terms & conditions as mentioned in the Bidding Documents.
- 3. The procurement will be carried out under PPRA Rule 36(a) Single Stage, One Envelope Procedure (Cost-Based Selection Method). All bids meeting the eligibility criteria shall be evaluated based on cost, and the contract shall be awarded to the lowest evaluated responsive bidder.
- 4. Bids must be accompanied by Bid Security @ 2% of the total bid value, in the form of a Demand Draft/Payment Order in favor of Chief Executive Officer (SEPCO).The bid shall remain valid for 90 days from the bid submission deadline and (30) days beyond validity of Bid.
