"HIRING OF TRANSPORT SERVICE"

1. Sukkur Electric Power Company Ltd. (SEPCO) invites sealed bids from registered and experienced transport service providers for the hiring of 30 vehicles (single & double-cabin Toyota pickups) on a monthly rental basis. The vehicles will be deployed round the clock with the DISCOs Support Unit (DSU) in SEPCO's operational areas.
2. The prospective bidder must:
 - Provide a copy of firm's registration certificates with relevant authorities.
 - Be registered with FBR (NTN & GST) and listed as an active taxpayer, complying with income tax laws.
 - Preference will be given to those firms who have more than 02 years of experience in providing transport hiring services to corporate or government entities.
 - Meet other terms & conditions as mentioned in the Bidding Documents.
3. The procurement will be carried out under PPRA Rule 36(a) - **Single Stage, One Envelope Procedure (Cost-Based Selection Method)**. All bids meeting the eligibility criteria shall be evaluated based on cost, and the contract shall be awarded to the lowest evaluated responsive bidder.
4. Bids must be accompanied by Bid Security @ 2% of the total bid value, in the form of a Demand Draft/Payment Order in favor of Chief Executive Officer (SEPCO). The bid shall remain valid for 90 days from the bid submission deadline and (30) days beyond validity of Bid.
5. Availability of Bidding Documents
Interested bidders fulfilling the above requirements can obtain the Bidding documents containing detailed Terms & Conditions, Method of procurement, procedure for submission of bids, Bid Security, Bid Validity, opening of bids, Evaluation criteria, Clarification / Rejection of bids, performance Guarantee etc can be obtained from the office of undersigned on submission of a written application along with Demand draft / Pay Order amounting to Rs: 3,000/- (Rs: 300/-) extra, outside city as a Courier charges) in the Name of Chief Executive Officer SEPCO Sukkur.
