Terms and Conditions

- 1. Bids are required to be submitted on Tender forms as per PPRA Rules 2004, which can be obtained from Administration Branch, 6th Floor, Collectorate of Customs Enforcement, Custom House, Karachi on payment of Rs. 5000/- (non-refundable) per set during office hours from the date of publication of this advertisement (22.05.2024 to 10.06.2024).
 - 2. Sealed bids must be dropped in the 'tender Box placed in the Administration Branch, Collectorate of Customs Enforcement, 6th Floor, Custom House Karachi by 10.06.2024 Upto 1100 hours. These bids will be opened on the same day at 1200 hours in the presence of bidders or their authorized representatives who may like to witness the opening up of sealed bids.

- 3. Following documents after attestation must be attached with the tender documents:
 - i. Copy of valid Sales Tax Registration.
 - ii: Copy of valid Income Tax Registration.
 - iii. Business Profile of last 3 years.
 - iv. Authority letter showing the details of authorized person.
 - v. Copy of CNIC of the authorized person.
 - vi. An affidavit confirming that the company is not black listed anywhere.
- 4. The competent authority reserves the right to accept or reject any or all bids in accordance with the provisions envisaged under Rule-33 of PPRA Rules 2004.
- 5. No bidder will be allowed to alter or modify his/ her bid after opening of the bids.
- 6. No conditional bids will be accepted.
- 7. The quantity of items to be purchased can be increased and decreased.
- 8. 2% security deposit of the bid value in shape of pay order should be submitted along with the bid, which will be refunded within 07 days to the unsuccessful bidders.
- 9. Successful bidders will be required to pay all taxes as per Government rules.
- 10. Successful bidders will be required to pay all duties & taxes as per Government rules along with the stamp duty 0.2% and shall furnish a bank guarantee/ pay order of 5% of the total amount of Bid value as performance guarantee which will be refunded after maturity of six month from the date of award of contract.
- 11. No bid shall be entertained after given cut of date and time.
- 12. Bids will be compared on a whole tender value.
