- 2. No bidding document will be sold/issued after the closing date.
- 3. In case of public holiday, the receipt and opening of tenders will be the next working day.
- 4. No bidding document will be issued through email, whatsapp etc.
- 5. Bids security @ 05% (Five percent) of bid price, in the form of Deposit at call, (CDR) in the name of Executive Engineer, Central Civil Division No. II Pak PWD Lahore, from any scheduled bank of Pakistan, should be attached along with the sealed bid, otherwise bid will be rejected.
- 6. The documents of the firm, CNIC, NTN, valid Pakistan Engineering Council License etc should be available with the intending contractors at the time of purchase of tenders, failing which bidding documents will not be issued.
- 7. Invitation to bid is also available at PPRA website www.ppra.org.pk.

If the bid amount of successful bidder is seriously unbalance in relation to the detailed estimate, the bidder shall have to furnish additional performance security equal to the difference of estimated cost and total bid amount in the shape of bank guarantee duly issued by any schedule bank of Pakistan besides furnishing detailed price analysis to demonstrate internal consistency of his rates as per Clause IB.28.4 of bidding documents.
